Grain Marketing

ValueAccess a Unique, Value-Based Marketing Tool for Grain Producers

[NOTE: A session on ValueAccess is scheduled for the spring meeting]

AgInsight is engaged in the development of an affordable, sustainable, process verified grain marketing system called ValueAccessTM that could provide U.S. grain producers with repeated access to developing markets for identity-preserved and traceable grain.

U.S. corn and soybean producers who participate in AgInsight's ValueAccess system will:

- Gain access to a unique, sustainable, value-based production and marketing system that is directly connected to the consumer.
- Gain the opportunity to potentially receive premium-based prices for at least some of their grain. Some of these opportunities will be in the form of contracts issued before planting. Others will be opportunities that arise during or following the growing season.
- Gain access to a low-cost, field-specific, electronic record-keeping system that provides complete traceability of grain and crop production practices.

The ValueAccess system provides grain producers with access to fluid markets by directly connecting them with a grain exporter and food processor. ValueAccess is a tool, that when utilized, could help stabilize and increase farm income. It provides U.S. grain producers with the means and the opportunity to capitalize on emerging premium-based pricing systems created by advances in biotechnology and increased consumer awareness of the origins of the food they eat.

Adding value to agricultural products to meet specific needs is often cited as a way to return economic viability to U.S. farms. In today's market, the greatest movement toward meeting specific end-use needs is building an infrastructure that accurately tracks grain from the field through the processing facilities, and ultimately to the shelf of the local grocery store.

Traceability and identity preservation of grain are no longer concepts limited to small-scale, organic-based production systems. They are now critical steps in the large-scale production of commodity grain.

Demand for this grain is expected to increase significantly in the next two years as member nations of the European Union adopt recently proposed legislation that focuses on traceability and labeling of GMO grain and products made from GMO grain. The legislation proposes that all food, feed, and highly refined oils produced from grain containing 1 percent or more GMO grain be labeled. Similar labeling guidelines have been proposed for Asia as well.

Countries such as Brazil and Thailand are attempting to position themselves as reliable suppliers of non-genetically modified grains, which could result in decreased demand for U.S. crops. If U.S. grain producers wish to maintain their status as the preferred supplier of grain for the world, they must regain the trust of the consumer.

ValueAccess gives U.S. grain producers access to emerging markets throughout the growing season to sell their grain at premium prices while at the same time addressing the wants and needs of the consumer.

Manure Management Plans

DNR Update

There are very few dull moments at the Iowa Department of Natural Resources. It seems like budget cuts, Legislator conflicts of interest, more budget cuts, departmental reorganization, proposed confinement sites near tourist attractions, and proposed nutrient standards for water bodies keep us on our toes. While independent crop consultants may not be interested in every little thing happening at the DNR, the DNR is working on a few things that you may be very interested in.

The DNR is moving ahead with changing the manure management plan (MMP) submission, approval and tracking process. As most of you are aware, the current MMP process involves time-consuming paper work and repetitive calculations. There is a backlog of MMPs to be reviewed and approved – and the funding for the MMP-reviewer staff positions expires on July 1, 2002. The DNR must find a 'new and improved' method for dealing with MMPs. Couple that issue with the Governor's grand plan to streamline government, and you'll find we're in a bind.

It has been *proposed* that after July 1, the MMP submission process be greatly simplified to facilitate a relatively painless process of doing your MMP online, submitting the MMP electronically and receiving approval (or notice of snags or disapproval) in a very short time span. The MMPs would be reviewed electronically via a computer program. If 'red flags' are sent up because information on the MMP is outside acceptable ranges, further investigation by a DNR staff person would follow. It has also been *proposed* that the people currently reviewing MMPs would be shifted to the field offices, where they would attend to regularly scheduled site visits with confinement site operators to assure that MMPs are being followed, application records are being kept and MMP updates are recorded as necessary.

The intent of the proposed actions is to focus more on compliance with MMP requirements, rather than the current focus on plan submission. – The bottom line is that yes, people are submitting MMPs but we have no assurance that people are following the MMPs. Let's be honest – the important point of MMPs is to protect natural resources. Without the on-site follow-up and contact with producers, Iowa will never have that assurance.

You'll note that I have repeatedly used the word *proposed*. This is because the MMP proposition is still in the process of being formed. The one thing I've learned here on the government side of the fence is to never count your chickens before they hatch – and this is definitely still an egg. I liken putting forth a proposal to raising a child...you pour blood, sweat and tears into the formation of the little tyke, and then one day they strike off on their own and all you can do is pray that they return with a minimal amount of tattoos and body piercing so you can at least recognize them.

At the very least we anticipate having the forms available in electronic format for electronic submission. The exact details have yet to be worked out as to how we'll handle the July 1 deadline and continue reviewing MMPs. I will keep you informed.

In guessing the direction of technology, it is wise to ask who is in the best position to profit the most.
